Sub. : Prevention of Sacrifice / Slaughtering and transportation of the Animals in violation of the Laws, Rules, Regulations, directions - Reg.

It is a fact that the large number of animals are sacrificed / slaughtered on various occasions like Bali Pratha (बलि प्रथा), Baknd festival etc. in violation of the Laws, Rules, Regulations, directions all over the country. It is also noticed that during the transportation of animals, the owner of the animals does not follow the animal welfare laws and Transport of Animals Rules resulting in cruelty to the animals. The animals are subjected to various cruelties and some of the animals even die during transportation.

Unscrupulous persons are carrying on the business of illegal slaughtering in violation of the Prevention of Cruelty to Animals Act, 1960 and the Rules made thereunder. Such unlawful practice is also against the local Municipal Acts and Rules and the directions of the Supreme Court made in Writ Petition (C) No. 309 of 2003 dated 27th August 2013 in the matter titled as Laxmi Narain Modi v. Uol & Ors., 2013 (10) SCC 227. Such violation is also against the spirit of Article 48, 48 (a) and 51 A (g) of the Constitution of India.

Further, the Board has constituted an Inspection Committee to visit and inspect any place(s) all over the country as per the direction of the Board to report cases of illegal transportation and sacrificing / slaughtering of animals in violation of the Laws, Rules, Regulations, directions. This Inspection Committee shall consist of the following Members:-

5. Shri Vijay Pal Singh, Deputy Director - Quality Control, Food Safety and Standards Authority of India (FSSAI)
6. Shri Chandra Shekhar, State Animal Welfare Officer, New Delhi

In addition to the above Members, the concerned States / UTs are requested to nominate the following officers as member of the Inspection Committee during their visit in their State/UT:

7. The Commissioner / Director, Transport Department or his representative not below the rank of Joint Commissioner / Joint Director.
8. The Commissioner of Police / Superintendent of Police or his representative not below the rank of Assistant Commissioner of Police / Deputy Superintendent of Police.
9. The Deputy Commissioner / District Collector / District Magistrate or his representative not below the rank of Additional Deputy Commissioner / Additional District Collector / Sub-Divisional Magistrate.
10. The Director, Animal Husbandry or his representative not below the rank of Joint Director.
11. The Commissioner, Municipal Corporation / The Chairman / President, Municipal Committee / Council not below the rank of Executive Officer / Secretary.
12. The Member Secretary or Senior Rank Officer of the State Pollution Control Board

It is therefore requested to direct all the concerned authorities to take all precautionary measures to strictly implement the Animal Welfare Laws to stop illegal sacrificing / slaughtering and transportation of animals in violation of the Laws, Rules, Regulations, directions and provide all assistance to the above Inspection Committee and also to take stringent action against the offenders violating the animal laws viz. PCA Act, 1960, the Transport of Animals Rules 1978 and its amendment, Slaughter House Rules, 2001, Motor Vehicle Act, Municipal laws and Food Safety & Standards Authority of India directions for slaughtering of animals during Bali Pratha (बलि प्रथा), Bakrid festival etc.

Action taken in this regard may kindly be intimated to the Board.
