The Secretary, AWBI started the meeting with greetings to all the members. She expressed her gratitude towards Shri S.P. Gupta, former Chairman, AWBI and welcomed Dr. O. P. Chaudhary, Chairman, AWBI. She requested the Chairman to give his introductory / welcome remark to the members.

The Chairman welcomed the Members of the Board and apprised the Members about the working of the Board after assuming the charge of Chairman, AWBI. He further stated that we will work as per the mandate of the Board with full devotion and transparency. Chairman requested the Secretary to start the proceedings of the meeting.

committee to know the impact of training. The feed back of the training also be obtained for consideration in the committee.

With regard to the compulsory registration of Animal Welfare Organisations and foreign organisations working in the country for animal welfare, the Members decided that the Legal Committee will examine the matter and place the report before the Board meeting. If the matter is of urgent nature, the Chairman may take appropriate decision.

Further, the Board members unanimously agreed that Technical Committee is not required as of now. Also, the Jallikattu Inspection Committee will be reconstituted for the year 2019-20 before commencement of Jallikattu.

It was decided that 40% of the Members shall form a quorum at every meeting of the Committees.

In addition, it was agreed that all the members other than the Board members will be co-opted for the Committee(s) as per the Rule 16 of the Animal Welfare Board (Administration) Rules, 1962.

Item No. 7: Consideration of matter relating to issue of Colony Animal Care Taker Identity Card.

After discussion on the each pros and cons of the matter, the Board has decided to restart the process of issuance of Colony Animal Care Taker Identity Card to the Volunteers who want to feed stray animals in their localities only during hours specified by the AWBI and on suitable sites for feeding the stray animals.

General Discussion with the permission of Chair:

Shri Sunil Mansinghka opined that the issues regarding cruelty to animals in the field and action taken should be informed to the Board Members from time to time. He also informed that most of the Gaushalas are facing shortage of space for sheltering of animals.

The Members suggested that news / report about animal welfare activities to be obtained from the Members, Co-opted Members of the different committees, Honorary Animal Welfare Officers of the Board for inputs in AWBI News Letter and other magazines.

It was decided that soft copy of the Newsletter to be sent to the Members, Co-opted Members, Honorary Animal Welfare Officers of the Board, AWOs and other animal welfare activists for wide publication. The Members discussed about issuing of pre-shoot permission and NOC under Performing Animals Registration Rules 2001. It was decided that efforts to be made to start online processing of applications under Performing Animals Registration Rules 2001 within three months.

The Members discussed about the nomination of Hon'ble Members of Lok Sabha and Rajya Sabha to the Board and decided to take up the matter with the Ministry for necessary action.

Shri Girish J. Shah, Member has raised the issue of Live Stock Export in details. Dr. S.K. Dutta, Deputy Commissioner (Animal Welfare) informed that the concerned offices have been briefed about the policy of Government of India and compendium of all rules and regulations for export of live animals were circulated to all the State Governments.

The representative of ICMR has briefed about new method for painless sterilization on male dogs. The Chairman requested the Member to provide scientific data in this regard for consideration of the Board.

Dr. Praveen Malik, Animal Husbandry Commissioner suggested that agenda points for the meeting to be circulated to the Members of the Board for discussion in the Board meetings and the Members should intimate any specific agenda to be taken up for discussion in the future meeting.

Shri Rajeev Gupta, IAS (Retd.) suggested that Executive Committee Meeting of the Board may be conducted for discussion of important pending issues.

Dr. Vallabhbhai Kathiria, Chairman, Rashtriya Kamdhenu Aayog expressed his thanks to the Chairman and all Members of the Board for inviting him and Shri Hukam Chand Sawla as special invitee. He suggested that both the organisations can work together for the benefit of speechless animals. He further opined that the Board and Aayog should work together to evolve the methods to address the issues of mutual interest for better contribution to the field of animal welfare.
